

We are called upon also to consider a line of decided cases supporting the proposition that the owner of property is entitled by law to the undisturbed and exclusive enjoyment of his estate, and to keep out all trespassers, this being a part of his property in his estate; but clearly they do not apply, as defendant in error was in no sense a trespasser upon the property of Hunter or his property rights, when proceeding by authority of law to acquire title to his property by condemnation for a public use. Citation of another line of cases is also made in support of the contention that the quiet use and enjoyment of property is to be separated and distinguished from the property itself, so as to entitle the owner to just compensation for both when the property is taken in the exercise of the power of eminent domain; but, again, we have to say that the cases do not apply to this case.
